When the sponsor and sponsored immigrant are married, alimony, child support, and equitable distribution of income-producing assets must be included in the sponsored immigrant's available support. Id. Thus, the Affidavit of Support is not enforceable if the sponsored immigrant's income meets or exceeds the 125% poverty level.
